## MUGA Hirer's Privacy Notice

When you hire the Multi-Use Games Area at The Recreation Ground in Pirton the information you provide (personal information such as name, address, email address, phone number) will be processed and stored so that it is possible to contact you and respond to your correspondence, provide information, send invoices and receipts relating to your hire. Your personal information will be not be shared or provided to any other third party.

### The Council's Right to Process Information

### Information Security

Pirton Parish Council takes care to ensure the security of personal data. We make sure that your information is protected from unauthorised access, loss, manipulation, falsification, destruction or unauthorised disclosure. This is done through appropriate technical measures and relevant policies.

We will only keep your data for the purpose for which it was collected and only for as long as is necessary, after which it will be deleted.
